1 PUBLIC HEARING OAKLAND, CALIFORNIA 2 FRIDAY, APRIL 23, 2010 - 10:02 A.M. 3 4 5 MS. OVERPECK: Good morning. I think that we'll go ahead and get started today. 6 7 Thank you everyone for coming. This is the hearing on the Division of Workers' Compensation's Proposed Electronic and 8 9 Standardized Medical Treatment Billing Regulations. 10 My name is Destie Overpeck. I'm the chief counsel. Sitting next to me is Carrie Nevans, the Administrative 11 12 Director. This is Jackie Schauer, the attorney who has done 13 the bulk of the work on these regulations, and Sue Honor, who 14 is our Medical Unit Manager. 15 Also here today is Maureen Gray, who is our Regulations Coordinator. If you have any written comments you 16 17 want to turn in this morning, just hand them to her right now, 18 and she'll pick them up. And our court reporter is Kim Miller. 19 If you are going to speak today, please give her a business 20 card, if you have one, or write your name down and hand it to 21 her so we get your name and the company that you represent 2.2 correct. 23 The hearing today will last as long as there are people present who want to speak. I don't think it will go all 24

day, but if it does, we will be here until five o'clock.

7 The purpose of the hearing is to receive comments on 8 the proposed regulations, and we welcome any comments that you 9 have. Comments both oral and written receive the same weight. 10 We will consider all of them in determining whether or not any 11 additional changes are needed to these regulations. Please 12 restrict any comments you have to the regulations themselves.

We don't expect to enter into any discussion with you today on them. However, we might ask questions if we need clarification on something you have said in your comments.

When you come up to speak for comments, please come up to the podium and speak into the microphone.

18 There are sign-in sheets at the front. Please make 19 sure you signed in and checked the box "yes" if you want to 20 comment. Everyone who signed in we'll be sure to include if we 21 have any additional changes and as the rulemaking continues. 2.2 So I'm looking at what I was given as the sign-in 23 sheet, and I don't see anyone who checked the yes box. 24 Is there anyone here who wants to comment? 25 (No response.)

9	there's nothing in the electronic billing statute that gives	
10	you a break on the 15 days.	
11	MS. CASTRUCCIO: We are treated the same as insurers and	
12	private self-administered employers, right?	
13	MS. OVERPECK: Under the statute, yes, so also in	
14	regulations.	
15	MS. CASTRUCCIO: Thank you.	
16	MS. OVERPECK: Anybody else?	
17	(No response.)	
18	MS. OVERPECK: Since nobody has said that they would like	
19	to make a comment, we will go ahead and close the hearing.	
20	Thank you everyone for coming.
