# THIRD NOTICE OF AMENDMENT TO TEXT OF REGULATION

#### SPECIAL INVESTIGATIVE UNITS

April 21, 2020 REG-2018-00023

On July 19, 2019 the Insurance Commissioner issued a Notice of Proposed Rulemaking, proposing to adopt amendments to Title 10, California Code of Regulations ("CCR"), Chapter 5, Subchapter 9, Article 2, sections 2698.30 and 2698.33-2698.41: "Special Investigative Units."

On November 6, 2019, The Commissioner issued a Notice of Amendment to Text of Regulation proposing changes to sections 2698.30, 2698.33, 2698.36, 2698.37, and 2698.39 of the proposed regulation.

On January 31, 2020, The Commissioner issued a Second Notice of Amendment to Text of Regulation proposing changes to subsections 2698.30(f), 2698.33(d), 2698.36(a)(5)(F), 2698.39(f), and 2698.40(b)(5) of the proposed regulation.

# **NOTICE OF AVAILABILITY OF AMENDED TEXT**

#### PUBLIC COMMENT INVITED

The Commissioner now proposes to make additional changes to subsections 2698.30(f), 2698.33(c), 2698.33(d), 2698.36(a)(5)(F), 2698.38(d)(9)(B), and 2698.40(b)(7) of the proposed regulation, and solicits written comments on only those changes. The Commissioner believes the changes made are sufficiently related to the original text such that the public was adequately placed on notice that the change could result from the originally proposed regulatory action. Accordingly, pursuant to the provisions of Government Code section 11346.8(c), the Commissioner is soliciting written public comments on these changes.

A copy of the proposed sections to be revised, with the proposed changes clearly indicated, is attached to this Notice, and will be available for public inspection and comment for at least 15 days before the proposed regulation is adopted.
